

Fall Connect 2016 Sweepstakes

OFFICIAL RULES

No purchase, obligation or transaction necessary TO ENTER THE SWEEPSTAKES.

Promotion Period: Fall Connect 2016 ("Sweepstakes") begins October 1, 2016 and ends November 30, 2016. Entries received prior to or after the Promotion Period are not eligible for the Sweepstakes.

How to Enter: Individuals will receive an automatic entry into the Sweepstakes when they log into BMI Federal Credit Union My Finance Tool between October 1, 2016 and November 30, 2016, and have added at least one Spending Target to your Budget. One entry per household.

BMI FCU and contest sponsor – Debtfolio, Inc. dba Geezeo – are not responsible for entries that are lost, misdirected, delayed, destroyed, deleted, erased, stolen, or unreadable. BMI FCU and Geezeo assume no responsibility for any error, problem, or malfunction (human, technical, or otherwise) which may occur in the creation, maintenance or processing of Sweepstakes entries, or which prevents entries from being created. Eligibility: Entries are open to the general public. No purchase necessary. To qualify for the Sweepstakes, entrants must be a resident of the 50 United States (D.C.), Guam and Puerto Rico and be 18 years or older.

Employees, Board members and consultants of BMI FCU and its subsidiaries, and their family members within the same household are not eligible to win.

Winners need not be present and will be notified by e-mail, mail or telephone within 5 business days of selection. If a winning individual does not affirmatively accept his or her prize in writing or via e-mail within 10 calendar days of notification, an alternate entrant will be selected at random in his or her place from all eligible entries received.
